# 2023/01-3 Minutes of the Council meetings dated November 16th 2022

It was proposed <sup>(JW, seconded TH)</sup> and unanimously **approved** that the Chairman sign the Minutes.

### 2023/01-4 Reports

- 4.1 **Cambridgeshire County Councillor's report**. MS reported that:
  - Following the adoption of 20 m.p.h. as the default speed limit on new residential roads, the application process for new 20mph zones on existing roads is expected to open in February; details regarding costs are yet to be determined.
  - National Highways officers were prepared to attend PC and public meetings to speak about the upgrade of the A428.
  - She would speak with Highways about concerns over their input to planning applications and feedback to PD.
- 4.2 **South Cambs District Councillor's report.** PS reported that:
  - The upgrade to the A428 was delayed as it continued to be subject to a legal challenge.
  - Council Tax would be rising by 3.4% to try to achieve break even in the DC budget.
  - A £12 increase in Band D houses was proposed to fund better bus services.
  - The congestion charge consultation had received many thousands of responses and it would take some time for these to be analysed.
  - The first proposals in the new Local Plan envisage a need for an increase in the number of new houses required in South Cambs, however water supply is a problem and proposals for piping water from Grafham Water and the construction of a new Fens reservoir by 2035 were under consideration

### 2023/01-5 Village Matters

#### 5.1 Community Flood Plan

PW introduced the draft Flood Plan; arising out of consideration of the draft it was agreed that:

- The Flood Group be recognised formally as a PC Working Group.
- A small Steering Group comprising parish councillors and Flood Group members be established to discuss the detail in the plan and to report back to the PC; TH and JH volunteered to be the PC's representatives.
- A balance had to be struck between those things which the PC undertakes and measures
  which residents could be expected to take to protect their own property or for which they
  have riparian obligations.
- From the £3k which had been allocated for flood prevention in the current financial year, a new shed be purchased at a cost of £1070.83 + VAT.
- The Steering Group to consider and report back on the purchase from the same allocation of a limited number of sandbags (a single pallet?) and a flood trigger.
- Provision be made for a budget of £6k for flood prevention for the forthcoming financial year.
- Insurance cover for individuals with responsibilities under the flood plan be investigated by the PC once these were clearer.
- With regard to possible funding, that MS's suggestion that she arrange a meeting between PW and John Winfield of Cambs CC was welcome.
- 5.2 **Maintenance in the village**. JH reported that he had 12 volunteers to undertake the list of maintenance tasks that had been identified.
- 5.3 **King Charles' III Coronation**. Noted that a bring your own food and drink street party in Brook Street on Sunday, 7 May was being organised for everyone in the village and that an article would be put in the next edition of the ET.

#### 2023/01-6 Communications

- 6.1 Further to the letter from Rev N Di Castiglione addressed to all councillors dated 15 December 2022, it was agreed nem con to request that SCDC takes over the responsibility for the management of the closed churchyard under the provisions of the Local Government Act 1972, sections 215(2) and (3).
- 6.2 With regard to the suggestion in the letter that the PC meet the cost of horticultural care, it was confirmed by JH that, in fact, he would continue to bear this. As regards insurance cover for injury for people passing through the churchyard or possible damage to the church building most particularly from damaged trees, PD reported that advice had been received from the PC's insurers. They indicate that cover could be provided if the PC wished to accept responsibility for their maintenance; but they also drew attention that ownership together with its attendant responsibilities remained with the church and to the importance of undertaking risk assessments. Agreed that PD discuss these matters further with the Rector.
